The 91st Department Convention was once again held at the I.U. Campus in Kokomo, IN on Saturday June 3rd. Following the lengthy reading of last years minutes, two corrections were needed. The Treasurer reported we have 100 members in the Indiana Department.

Secretary Barbara received Communications from National Department President Leslie Dean, Senior Vice Pat Mullenix, and a lovely Thank-you card from the graduates of Knightstown—signed by all 17.

Since it is customary to give each of Knightstown's graduates a card and \$10 from the Department—but the number of graduates varies each year—a motion was made by Joan Davis that the Treasurer can dispense the total amount needed for graduation at \$10/per grad. until otherwise changed. (seconded by Vickie Day— motion passed) Those sisters with numerous years of membership were recognized and a milestone ceremony was performed by President Beverly for Ester Cook (50 years) and Barbara Moore (25 years). In attendance were 6 Past Department Presidents and each was pinned with an orchid at the alter.



# Article in the Wabash Plain Dealer Wed. August 9, 2006

Pvt. Joseph Sweet was remembered and honored at a service commemorating his new headstone, on Aug. 6 at Mississinewa Memorial Cemetery.

The Service was conducted by the Rebecca Otis Tent No. 54, Daughters of Union Veterans of the Civil War 1861-1865, Fort Wayne. Patriotic Instructor Loretta McCann led the group in the Pledge of Allegiance, followed by President Vicki Layman who read a tribute from "The Daughters" and the poem, "When the Boys in Blue are Gone" by John Hendricks, a former member of Co. H, 89th Indiana Vol. Inf.

Karen Pinkerton Tatro, Tent member and great-great-great-granddaughter of Joseph Sweet gave the welcome and presented a brief biography of Sweet.

Sweet was born in Ohio and moved to Wabash County in the 1840s. He married Anna Huddleston and they had six children. Sweet served with Co. G, 130th Regiment, Indiana Vol. Infantry. He died in 1864 in a field hospital in Nashville, TN.

Wabash American Legion Post # provided a color guard, comprised of Kent Mullett, Willie Davis and Burt Myers, who performed the presentation of the colors and the military salute.

# Civil War descendants meet at Brookside Park

RENSSELAER - Descendants of Shelby Grant, a well known local Civil War veteran, met recently at Brookside Park for a Grant cousins' reunion.

The highlight of the reunion was placing a Grand Army of the Republic marker and flag on Shelby Grant's grave site in Weston Cemetery.

Vickie Day, Grant's great-greatgranddaughter, and Margaret McClellan, Grant's great granddaughter, members of Daughters of Union Veterans of the Civil War 1861-1965, Tent 54 Fort Wayne, conducted the DUVCW Union Veteran Memorial service in his honor. A bugle used during the war was also placed on the grave during the service.

At the age of 18, Grant enlisted for three years on August 9, 1862 with Company A, 87th Regiment Indiana Volunteers. He was mustered in on August 31, 1862 and given a disability discharge on April 21, 1864. Despite his injuries, Grant enlisted again on March 6, 1865 with Company H 155th Regiment Indiana Volunteers at Michigan City. He was mustered out as a Sergeant August 4, 1865. On March 24, 1926, Grant died in Jasper County at the age of 82.

Shelby Grant and his brother, Thomas Grant's names are both inscribed on the Milroy Monument located in this city.

Local Grant descendants attending the reunion were Katie Shearer Elijah, David Shearer and Jason Elijah. Other descendants attending were Linda Hughes from Carmel, Jack Shearer from Valparaiso, Nancy (Shearer) Myers from Troy, Mich. and Lois (McCellan) Fox from Bedford.
